- On last year's student registration certificate if your were studying in France.



- If the person of your choice pays the CVEC on your behalf, you will receive an e-mail and will be able to download the certificate.

# STEP 5 - I need to obtain an acknowledgment of payment by exemption.

Student exempt from paying the CVEC but who must complete the online procedure on the website in order to obtain an acknowledgment of payment by exemption:

- students with scholarships based on social criteria managed by the CROUS (scholarship holders from the Ministries of Higher Education, Culture or Agriculture),
- students with **scholarships from the French government** (scholarship holders from the Ministry of Foreign Affairs)
- scholarship holders financed by the regions for paramedical, health and social training,
- refugee students, students benefiting from subsidiary protection and students registered as asylum seekers.

The following are not exempt from the CVEC:

- Foreign government scholarship holders (BGE)
- Scholarship holders from a private structure (e.g. foundation).



## STEP 5 - I need to obtain an acknowledgment of payment by exemption.
